## AGREEMENT FREESAT FOR FREE 100% CASHBACK

The following constitutes the basis of agreement between, you, the customer, and Norfilms (**Northern Filmmakers Limited**).

This Agreement governs the nature of the cashback made to and accepted by you upon your approval of the purchase of one or more items offered to you by the Norfilms Freesat For FREE offer (**the offer**).

### The Agreement

1. **Legal age.** It is assumed, and confirmed by your acceptance of this offer, that you are of legal age to enter into this agreement.
2. **Liability.** Norfilms is not be liable for any losses, damages, claims, etc., to or made by you if you are not in a legal position to enter into this agreement.
3. **Cashback.** The cashback is a full refund on your purchase price under the offer. It does not include any excess charges made in addition, such as excess shipping, tax or other costs, unless specifically stated.
4. **Limited offer.** This agreement is limited only to the offer and no other sales or service transaction that may be entered into between you and Norfilms.
5. **Your approval.** This agreement comes into effect only upon your approval of the goods purchased by and delivered to you.
6. **Cancellation.** Should you disapprove of and return the goods as unsatisfactory, or make any other claim of a comparable nature this agreement shall not be valid; it will be cancelled; and Norfilms shall have no obligation to satisfy any commitment made under this offer.
7. **No investment.** In accepting this offer you understand and accept that this is not an investment. Although Norfilms will make investment in film and television production and environmental initiatives with the funds raised from the offer, no sale of shares or any comparable securities is made to you by the offer; nor is any share in any subsequent investment offered to you in taking up the offer.
8. **Use of funds.** You accept that in making used of the funds raised from your participation in the offer Norfilms will:-
  - a. Endeavour to provide the cashback through the recoupment of costs and profits from the use of funds.
  - b. Set aside a contingent reserve to meet the cashback irrespective of any other activity.
  - c. Place the contingent reserve in the hands of a secure third party to ensure safe cashback.
9. **Non-redemption.** The offer is a non-redemption one. You are not obliged to present any claim for the offer at any specific date or location.
10. **Cashback fulfilment.** Norfilms will provide you with your cashback as soon as possible, subject to:-
  - a. The amount of funding raised from the offer.
  - b. The income from production and related commercial activities.
  - c. The success of the contingent fund.
  - d. The achievement from one or more of the above in accumulating sufficient funds to meet the obligations of the offer to all customers who have successfully entered into this agreement.

11. **Third party.** The management and settlement of the offer funds will be placed in the hands of a secure third party; and, in the event of business failure of Norfilms the offer will be fulfilled by the third party.
12. **Confirmation of cashback.** You will receive a confirmation of this from the third party and a confirmation of your participation in the offer and registering your entitlement to the cashback when you have approved your receipt of the offer goods.
13. **Not securities.** This confirmation is not a security or share. It is not transferable and therefore it is not tradable on any public market. You may not trade or exchange it, sell it, or make use of it in any fashion without prior permission of either, primarily, Norfilms or, secondarily, the third party.
14. **Amendment fee.** The third party may charge a fee for any amendments to any details or ownership of the cashback.
15. **Payment of cashback.** The cashback will be made by a suitable means of financial transfer at the time of settlement.
16. **Contact details.** If you change your contact details, especially your address, before settlement of the offer you are solely responsible to notify Norfilms or the secure third party of your new contact details so that the cashback can be made successfully. If you fail to give up-to-date and accurate contact details neither Norfilms nor the third party has any liability for costs or losses incurred by you as a result.
17. **Notification address.** You may notify either Norfilms or the third party at the addresses published on their respective web sites, or issued to you at such times as decided from time to time by them.
18. **Non-refundable.** The offer is not refundable before settlement of the offer - funds cannot be returned to you before the offer is settled to all customers.
19. **Fraud protection.** If any suspicion of fraudulent activity arises relating to your cashback, such as through the use of false identity documentation, the cashback may be suspended pending satisfactory enquiry.
20. **Enquiry.** If such enquiry concludes that you have willingly participated in an attempt to defraud either Norfilms or the third party then both reserve the right to seek damages from you for any costs incurred as a result of your actions.
21. **Force Majeure.** Norfilms is not liable to complete any part or all of this agreement or settlement of the cashback if prevented from doing so by any event or force outside of its control, including, but not otherwise excluding, any acts of nature, god, wars, technical failure, failure of provision by parties outside of its direct control, civil or economic disruption, terrorism, etc.
22. **Amendments.** This agreement may be amended from time to time by Norfilms in light of legal advice, amendments to consumer or other laws, as a result of judicial decision or other factors. Upon amendment the new terms of agreement will come into effect for all agreements issued to-date and subsequently.
23. **Waivers.** No waiver by Norfilms of any breach of this agreement by you shall be considered as a waiver of any subsequent breach of the same or any other provision.
24. **Provisions.** If any provision of this agreement is held by any competent authority to be invalid or unenforceable in whole or in part the validity of the other provisions and the remainder of the provision in question shall not be affected.
25. **Jurisdiction.** The agreement shall be governed by the laws of England, and you agreed to submit to the non-exclusive jurisdiction of the English courts.
